An ordinance appropriating for all assessment purposes for all town purposes for Afton-Pierce Multi-Township Assessment District, DeKalb County, Illinois, for the fiscal year beginning April 1, 2025 and ending March 31, 2026.

BE IT ORDAINED by the Board of Trustees of Afton- Pierce Multi-Township Assessment District, DeKalb County, Illinois.

SECTION 1: That the amounts hereinafter set forth, or so much thereof as may be authorized by law and as may be needed or deemed necessary to defray all expenses and liabilities of Afton Pierce Multi-Township Assessment District, be and the same are hereby appropriated for the assessment purposes of Afton Peirce Multi-Township Assessment District DeKalb County, Illinois, as hereinafter specified for the fiscal year beginning April 1, 2025 and ending March 31, 2026.

Forty-Five Thousand Three Hundred Seventy-Nine Dollars and 00/100 for the fiscal year beginning April 1, 2025 and ending March 31, 2026.

SECTION 6: That section 3 shall be and is a summary of the annual Appropriation Ordinance of this Multi-Township Assessment District, passed by the Board of Trustees as required by law and shall be in full force and effect from and after this date.

SECTION 7: That a certified copy of the Budget & Appropriation Ordinance shall be filed with the County Clerk within 30 days after adoption.

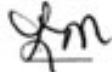

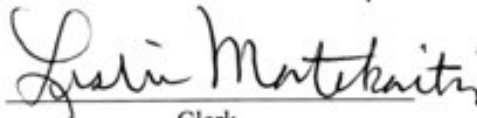
