The Septic and Well Committee work is related to the quote in hand for septic work. Emergency Warning committee in process of making several more calls. Broadband Committee has done some research, Randy suggested they contact County for information on broadband work done by County. Nothing new on building.

Highway Commissioner's Report – Calcium Chloride scheduled for application on certain roads, beginning tomorrow. Results of OSHA review all good.
